

Regulations

CLOSING DEADLINE: May 10, 2024

MASTERCLASSES: FEES

Instruments

Down payment: € 200 [to be paid at the time of enrolment and including the membership fee] Attendance fee: € 330 [to be paid by June 1, 2024]. If you enrol and pay the registration fee by April 15, 2024, the attendance fee will

be € 300 instead of € 330.

Chamber Music

Down payment: € 75 per component [to be paid at the time of registration and including the membership fee] **Groups already formed** Attendance fee: € 175 per group member [to be paid by June 1, 2024]. **Individual instrumentalists** Attendance fee: € 225 [to be paid by June 1, 2024].



<u>Auditors</u>

Fee valid for the entire period of the Garda Lake Music Festival 2023: € 175 [to be paid upon enrolment].

NOTES

Refunds are provided only in the event that the organisation is forced to cancel the course for reasons beyond the students' control.

Payment of the attendance fee can be made by bank transfer, indicating the name of the student and the chosen masterclass, or on site at the Festival Secretary's Office on the day of arrival [cheques or credit cards are not accepted]. The courses are open to instrumentalists of all nationalities without age limits. Masterclasses will be conducted according to the following rules.

LESSON MANAGEMENT

Students are divided into full students and auditors.

Each masterclass will be activated ONLY WITH A MINIMUM OF 8 ENROLLMENTS.

Each teacher guarantees a minimum of 3 lessons per student lasting approximately one hour and the timetable will be established by each teacher according to the needs of each class.

THE FESTIVAL WILL PROVIDE EACH PUPIL WITH A COLLABORATING PIANIST.



Interested parties are requested to clearly indicate the date and time of arrival and departure on the registration form. In the absence of such information, lessons assigned by the secretariat and not taken will not be made up or refunded.

Those interested must communicate at the time of enrolment the repertoire they intend to present. Students are required to bring scores, parts and piano reductions of the pieces they intend to play. Students are invited to email copies of parts for piano collaborators.

Admission

Attendance at the masterclasses is subject to the teacher's assessment following the viewing of the video, which must be sent by email no later than the registration deadline [max. 10 minutes, free programme, YouTube link].

The teacher's judgement for admission is final and irrevocable.

Students participating in one of the masterclasses may attend the lessons of any other lecturer as auditors free of charge.

Those not admitted may attend the masterclasses as auditors. Auditors will have access to all classes.

Classes will be held in presence; each member is entitled to a minimum of 3 lessons. At the end of the masterclasses, a certificate of attendance will be issued to students who have attended all the lessons.

During the courses, students are responsible for their own safety and the safety of their instrument: the Festival is not liable for damage to property or persons.



Student concerts

Numerous concerts will be organised during the Festival and some of them will be reserved for the best students. The performers will be chosen at the sole discretion of the teachers. All selected students will be required to wear concert attire.

Selection procedure

Each candidate **selected by the Festival teachers** may participate in one of the two dates, bringing **a complete concerto of their choice**. One candidate will be selected on each audition date (2 candidates in total).

The Artistic Direction will choose the winner from the two candidates thus selected. The winner will be entitled to 4 concerts with the Orchestra dei Pomeriggi Musicali, starting with the first concert on July 25, 2024.

Dates of the other concerts: July 26 – 27 – 28, 2024.

Chamber Music

The Chamber Music course is open to both established groups and individual instrumentalists.

<u>Established groups</u>: each group is entitled to 4 lessons with Avos Project Chamber Music teachers or with others who will take part in the Festival.

<u>Single instrumentalists</u>: participation is open to pianists, string and wind instrumentalists. The masterclass will consist of inclusion in mixed chamber groups (teachers/students) that will take part in the Festival concerts.



In order to be admitted, a pre-selection YouTube video of at least 5 minutes in length must be submitted. The parts of the pieces to be played will be sent by email **by June 15, 2024**.

Rules for the stay of foreigners in Italy

According to international agreements for medical assistance, foreign students from European Community countries are required to provide the E/111 form. Students from non-EU countries, on the other hand, must present their health insurance to the Secretariat.

The scores for the piano accompanist that you intend to use during the course must be sent by email.



Image, audio and video recording
